## Board of Health

Commissioner Linke announced that the Board is sitting as the Grand County Board of Health.

Public Health Director Abby Baker reported that the previous Public Health Order has been lifted. The level orange for last call for on premise liquor sales at restaurants remains at 10 p.m.

The order has updated capacity for gym and fitness to 25 percent of capacity.

Some of the winter season sports at the high schools are being allowed.

The testing team has been doing a lot of testing for the last two months.

The current positivity rate is 9.9 percent. The current incidence rate is 767.74 for a population of 100,000.

Grand County Public Health has received 300 doses and have given out 280 and will complete the other 20 this afternoon. Public Health ordered 400 doses and will receive 100 doses. Denver Health got 100 vaccines and have given out 90. Byers Peak Family Medicine vaccine and are not sure when they will receive them. Middle Park Health received 840 doses and have given 330 doses. Middle Park Health has 230 vaccines to give out. Middle Park Health is providing doses to 70 plus category. (Middle Park Health is holding out some doses for second doses.) Middle Park Health is expecting another 200 doses.

Grand County has less than half of the vaccines needed to provide vaccines to the 70 plus population.

Commissioner Linke announced the Board is sitting as the Grand County Board of Commissioners.

### Fire Recovery Update

Emergency Manager Joel Cochran announced that Grand County received a Presidential Declaration authorization (DR-45-81)

The Board submitted its letter asking for major disaster declaration on November 17. That was updated on December 16. On the 15<sup>th</sup> of January, Mr. Cochran was notified of the disaster declaration being signed.

The Federal Coordinating Officer assigned to Grand County is Jon Huss. The public assistance request was authorized so the individual assistance request is under review by the Federal Coordinating Officer.

Economic Development Director DiAnn Butler stated that under economic recovery, there are three sub groups; small business task force, marketing and communication task force, and grant funding assistance task force.

Human Services Director Deb Ruttenberg stated that she has been working on individual needs.

Housing Authority Director Sheena Darland has been working on a survey to determine housing needs this spring.

Megan Ledin of the Grand Foundation is working on individual needs through the Grand Foundation.

Robert Davis of infrastructure services stated that there are a number of concerns that have been raised. Staff would like to do administrative approval for waiving building permit fees. The Board will discuss this further in a workshop.

Water Quality Specialist Katherine Morris reported that there is a little concern for people with indoor household use only wells to recover landscape.
