County residents Gerald and Lynnea Boyd made the following presentation:

Citation for Award of Grand County Challenge Coin to: Dennis Belz Director of The Colorado Baptist Disaster Relief

As the East Troublesome Fire raced through Grand County during those fateful days in late October of 2020, Dennis and his Colorado Volunteers immediately deployed to Granby to help man the County Disaster Assistance Center. You and your team's compassions in dealing with our County Residents as they struggled with the uncertainty of evacuation and the unknown of what had become of their homes was a great comfort. You provided hope in the knowledge that assistance was available regardless of their insurance coverage status.

Seemingly before the smoke had cleared, your team of "Yellow Shirts" could be seen throughout the County doing initial assessments for property debris cleanup. As your teams arrived from Colorado and many other states, they immediately went to work on cleanup. Trying to accomplish as much as possible, as you raced the winter weather clock. Once you were forced to stop operations due to weather you reluctantly departed, with the certainty that, "You are not forsaken We Shall Return".

As the snows receded this spring, revealing the blackened landscape, devastation, and destruction of so many homes; hope sprang anew, with the normal spring blossoms being replaced by the "Yellow Shirts return". Multiple teams have come from throughout the United States from as far away as Hawaii, to assist in our cleanup. Your only request was "Let Us Bring: Help, Hope, and Healing". and your only reward was that you and your volunteers touched the lives of so many of your fellow man and your kindness will never be forgotten.

You and your teams have assisted in the cleanup of more than 100 homes in the County and spent close to 20,000-man hours in the effort. This clearly demonstrates what this Challenge Coin Represents, Exemplary Service Above And Beyond All Expectation. It is our great honor and privilege to present you with this well-deserved Grand County Challenge Coin.
