**RESOLUTION NO. 2012PA-12-1**

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF GRAND SETTING AS THE PERMIT AUTHORITY AND GRANTING THE MUNICIPAL SUBDISTRICT OF THE NORTHERN COLORADO WATER CONSERVANCY DISTRICT ACTING BY AND THROUGH THE WINDY GAP FIRING PROJECT WATER ACTIVITY ENTERPRISE A PERMIT TO ENGAGE IN AN ACTIVITY PREVIOUSLY DESIGNATED AS AN ACTIVITY OF STATE INTEREST PURSUANT TO THE BOARD OF COUNTY COMMISSIONERS OF GRAND COUNTY RESOLUTION 1978-5-4, FOR THE 2012 WINDY GAP FIRING PROJECT (2012 WGFP).**

WHEREAS, on or about June 11, 2012, the Municipal Subdistrict of the Northern Colorado Water Conservancy District acting by and through the Windy Gap Firing Project Water Activity Enterprise (Subdistrict) submitted an application, under protest, for a permit pursuant to Resolution No. 1978-5-4, as amended, which permit is commonly referred to as a "1041 Permit". The application was submitted for approval of a "Municipal and Industrial Water Project" as contemplated in Chapter 5 of Resolution 1978-5-4, as amended; and

WHEREAS, the construction and operation of the 2012 WGFP constitutes a designated matter of State Interest pursuant to part 1 of Article 65.1, Title 24, of the C.R.S. 1973, and the "Grand County Administrative Regulations for Areas and Activities Designated As Matters of state Interest", adopted by Resolution No. 1978-5-4; and

WHEREAS, the proposed project is generally described as Chimney Hollow Reservoir located on the East Slope of Colorado identified in the Final Environmental Impact Statement (FEIS) for the Windy Gap Firing Project as the proposed action and any reservoir or reservoirs on the East Slope that are constructed as an alternative or in addition to the reservoir identified in the FEIS (Alternative Reservoir), provided that the cumulative active storage capacity of Chimney Hollow Reservoir and any Alternative Reservoirs does not exceed 90,000 acre feet. The use of the reservoir will cause additional depletions from the Colorado River in Grand County as well as repositioning of federal water of the Colorado Big-Thompson Project in a non-federal facility.

WHEREAS, the description of the project, a history of the purpose and need for the project, a description of the affected environment, and an analysis of the environmental consequences are discussed in detail in the Windy Gap Firing Project Final Environmental Impact Statement, November, 2011, prepared by the United States Bureau of Reclamation (hereinafter referred to as FEIS and made an exhibit to the public hearing file); and

WHEREAS, the operation 2012 WGFP will cause impacts in Grand County; and

WHEREAS, notice as required by Resolution 1978-5-4, as amended, of the filing of the application, and of all hearings are complete and properly published. Hearings were held on August 1 and 2, 2012, August 28, 2012, October 2, 2012, October 30, 2012, November 8, 2012, November 14, 2012, and November 20, 2012. A record was made of all hearings. The Board of County Commissioners setting as the Permit Authority has received oral evidence in the form of testimony and informational statements, and written evidence in the form of letters, statements, comments, recommendations, reports, studies, closing arguments and other documentation from the Subdistrict, County staff, various groups and governmental entities, and members of the general public; and;

WHEREAS, a list of exhibits received is attached hereto as "Exhibit A", and the closing arguments received are attached hereto as "Exhibit B"; and

WHEREAS, the evidence was considered based upon the probative value placed thereon by the Permit Authority, and the findings and resolution herein are based upon the record as a whole. References to exhibits and testimony herein are related to the record of proceedings before the Permit Authority. Such references are for convenience only, are not intended to be all inclusive, and do not necessarily include all portions of the record upon which the findings are based; and

WHEREAS, the application was reviewed under the Grand County Administrative Regulations for Areas and Activities Designated as Matters of State Interest (Grand County Land Use and Environmental Regulations);

WHEREAS, the 2012 WGFP must provide assurance that it complies with all required federal, state, regional and county planning policies regarding land use and water resources; and

WHEREAS, the Subdistrict must show that it is utilizing the water from the 2012 WGFP in the most efficient manner, including recycling, re-use, and conservation; and

WHEREAS, the Permit Authority has heard evidence that the 2012 WGFP will exacerbate or cause impacts in Grand County to the following :

- Water quality and quantity
- Aquatic habitat including temperature and flushing flow
- Distribution and composition of riparian and wetland vegetation
- Water clarity in Grand Lake

NOW THEREFORE BE IT RESOLVED, based on the evidence and testimony admitted at the public hearings, the Permit Authority of Grand County finds as follows with regard to the application submitted by the Subdistrict for the 2012 WGFP.

### **FINDINGS OF FACT AND PERMIT CONDITIONS**

Based on Subdistrict request for vested right and limitations stated in the application, Windy Gap Firming Project Intergovernmental Agreement (WGFP IGA), and evidence and testimony submitted at the public hearing, the following general conditions are applied and shall be met by the Subdistrict:

Condition 1. Water pumped under the original Windy Gap Project 1041 Permit cannot be stored at any time in Chimney Hollow Reservoir or any Alternative Reservoir for Windy Gap Firming Project (WGFP) that may be constructed as allowed in the IGA. In advance of each pumping season the Subdistrict will advise Grand County of the volume of water orders for that year for its Windy Gap Project participants and WGFP participants. All water pumped shall be assumed to be for the WGFP, which is subject to the 2012 Permit Conditions, unless the Subdistrict notifies Grand County as soon as it knows, but in advance of pumping, that water will be pumped under the original Windy Gap Project 1041 Permit rather than under the 2012 Permit. The Subdistrict will maintain daily records to account for and track the amount of water pumped

under each permit separately from the time that pumped water is introduced into Granby Reservoir until it is delivered to the individual participants with daily accounting records provided to Grand County on a monthly basis. Any change in the operation from WGFP to the Windy Gap Project will be for a valid operational reason, based on the Subdistrict's representation.

The 2012 WGFP Permit shall be suspended if the Windy Gap project is found to be in violation of the 1980 Windy Gap Project 1041 Permit. The 2012 WGFP may resume operation as soon as the Windy Gap Project is no longer in violation of the 1980 Windy Gap 1041 Permit.

Condition 2. The permit for the 2012 WGFP will be in effect for the life of the project and considered a vested right as long as the project is in compliance with the terms and conditions of all permits and approvals for the 2012 WGFP Permit.

Condition 3. The 2012 WGFP Permit is not transferrable to any other entity unless the County approves such transfer by Resolution.

Condition 4. This 2012 WGFP Permit shall allow construction of Chimney Hollow Reservoir (the reservoir located on the East Slope identified in the Final Environmental Impact Statement for the Windy Gap Firming Project as the proposed action) and any reservoir or reservoirs on the East Slope that are constructed as an alternative or in addition to the reservoir identified in the Final Environmental Impact Statement; provided that the cumulative active storage capacity of Chimney Hollow Reservoir and any alternative reservoirs does not exceed 90,000 AF, as long as the environmental impacts in Grand County are as reviewed and approved by the Permit Authority during the public hearing process for the 2012 WGFP.

Condition 5. The 2012 WGFP shall not exceed the volumetric limits stated in the WGFP IGA for the Windy Gap project and 2012 WGFP. The 2012 WGFP Permit is contingent upon the participant's use of water in compliance with the Windy Gap decrees and Colorado law.

### **Section 5-306-Grand County Regulations for Areas and Activities Designated as Matters of State Interest.**

#### **Criterion I(a) The Need For The Proposed Project Can Be Substantiated.**

The need for the proposed project is substantiated as follows:

The 2012 WGFP will firm the anticipated yield of the Windy Gap project.

The 2012 WGFP will meet a 34% water supply deficit for the project participants within the Northern Colorado Water Conservancy District boundaries by providing 90,000 acre feet of reservoir storage to provide a firm yield to the project of 30,000 acre feet.

The 2012 WGFP will firm the yield of the water provided to the Middle Park Water Conservancy District in the 1980 and 1985 Supplemental Agreements for the Windy Gap Project.

**Criterion I(a) has been satisfied.**

#### **Criterion I(b) Assurances of Compatibility of the Proposed Water Project with Federal, State, Regional and County Planning Policies Regarding Land Use and Water Resources.**

The Permit Authority finds that with regard to Criterion I(b) there are impacts caused by the 2012 WGFP, which would be mitigated with the following conditions which shall be met by the Subdistrict:

Condition 6. In order to satisfy the Subdistrict's compliance with its obligations under section

37-45-118(1)(b)(IV) of the Water Conservancy Act, the 2012 Permit shall not take effect until the WGFP IGA has been executed, and is conditioned upon the Subdistrict's continued compliance with its obligations under the WGFP IGA. The Permit Authority reserves jurisdiction with regard to this condition in the event any signatory to the WGFP IGA refuses to sign.

Condition 7. While the Subdistrict is not a party to the Grand Lake Clarity Agreement, the Permit Authority has relied on the Clarity Memorandum of Understanding in determining whether the 2012 WGFP complies with its 1041 Regulations; therefore, the 2012 Permit shall not be effective until the Clarity MOU, Clarity Supplement to the 1938 Repayment Contract and Contributed Funds Act Agreement (CFA Agreement) for executing the Colorado- Big Thompson (C-BT) West Slope Collection System Technical Review of Alternatives and Analysis and Plan of Study have been executed. The Subdistrict shall provide County with a status report, every two years, on the progress of meeting the State Water Clarity Standard for Grand Lake. The Permit Authority reserves jurisdiction with regard to this condition in the event any signatory to the applicable agreement(s) refuse to sign.

Condition 8. The Permit Authority has relied upon the Related Documents identified in the WGFP IGA in determining whether the 2012 WGFP complies with its 1041 Regulations; therefore, this 2012 Permit shall not be effective until those Related Documents have been executed or finalized, and Grand County has been provided with copies of same. The Permit Authority reserves jurisdiction with regard to this condition in the event any signatory for a Related Document(s) refuse to sign.

Condition 9. The storage of water in Chimney Hollow Reservoir shall not commence until the water court approves the Windy Gap decree as amended by incorporation of the WGFP IGA. The Subdistrict shall provide Grand County with documentation of this approval.

Condition 10. The 2012 WGFP Permit shall not be effective until issuance of necessary state and federal permits and approvals for the 2012 WGFP, and this 2012 Permit is contingent upon Subdistrict's continued compliance with those permits and approvals. If there is a conflict between a term and/or condition in the 2012 WGFP Permit and a state or federal permit or approval, the term or condition that is the more restrictive shall control, unless otherwise preempted. Subdistrict shall provide Grand County with copies of all approved federal and state permits and approvals issued for the 2012 WGFP, which shall be attached to this permit. Following is a list of anticipated state and federal permits and approvals (this may not be a complete list):

- Clean Water Act 404 permit
- Colorado Department of Public Health and Environment ("CDPHE") 401 certification
- Fish and Wildlife Mitigation Plan, C. R. S. § 37-6-122.2
- Water Conservancy Act, C.R.S. § 37-45-101 et seq.
- Amendatory Contract and companion documentation of Bureau of Reclamation determination of compliance with Senate Document 80
- Record of Decision issued by Bureau of Reclamation
- Record of Decision issued for Corps of Engineers

Condition 11. The 2012 WGFP Permit shall terminate and be in no force and effect if construction of Chimney Hollow Reservoir, as defined in Condition 4 of this 2012 WGFP Permit, has not begun within ten (10) years of the latter of the issuance of the Record of Decision for the 2012 WGFP by Bureau of Reclamation or by the Corps of Engineers.

Condition 12. Diversions and pumping associated with the 2012 WGFP must cease if the Grand County Water Apportionment provided by the WGFP IGA is not available for release in accordance with the WGFP IGA. In such circumstances, any Windy Gap Project Water delivered to Middle Park Water Conservancy District shall be delivered in accordance with the 1980 and 1985 Agreements in the water year (August 1 to July 31) following the pumping season in which

WGFP pumping was curtailed because the Grand County Water Apportionment provided by the WGFP IGA was not available for release in accordance with the WGFP IGA.

Condition 13. To show compliance with the 2011 Grand County Master Plan provision about Economic Base- Recreation and Tourism Based Industry, and Criterion 5-306(g) (Public Outdoor Recreation Areas), the County has relied upon the public access provided in paragraph IV D of the WGFP IGA.

Condition 14 . Compliance with the conditions in this 2012 WGFP Permit shall constitute compliance with the Northwest Colorado Council of Governments 208 Plan.

**Criterion I(c) Municipal And Industrial Water Projects Shall Emphasize the Most Efficient Use of Water, Including, to the Extent Permissible Under Existing Law, the Recycling and Reuse of Water, Urban Development, Population Densities, and Site Layout and Design Of Storm Water and Sanitation Systems Shall Be Accomplished In A Manner That Will Prevent the Pollution of Aquifer Recharge Areas.**

The Permit Authority finds that with regard to Criterion I(c) there are impacts caused by the 2012 WGFP, which would be mitigated with the following conditions which shall be met by the Subdistrict:

Condition 15. Prior to delivery of water through the 2012 WGFP, Subdistrict shall provide the County with documentation of conservation plans for all municipal project participants and lessees and shall continue to provide documentation that participants are complying with the Water Conservation Act with regard to updating the conservation plans as required by state law.

Condition 16. Subdistrict shall provide written notice to the County when units of the 2012 WGFP are sold or leased and verification that the new owner or lessee has complied with the Water Conservation Act.

Condition 17. Within 30 days of acceptance of this 2012 WGFP Permit, the Subdistrict shall provide the County with written documentation of how use of water for fracking satisfies criterion c of the Grand County 1041 Regulations, if at all.

Condition 18: This 2012 WGFP Permit is subject to the Subdistrict's compliance with the terms and conditions of the 1980 Agreement and 1985 Supplement that remain in effect after execution of the WGFP IGA.

**Criterion I(d) Provisions to Insure that the Proposed Water Project Will Not Contaminate Surface Water Resources.**

The Permit Authority finds that with regard to Criterion 1(d) there are impacts caused by the 2012 WGFP, which would be mitigated with the following conditions which shall be met by the Subdistrict:

Condition 19 . See condition #7.

Condition 20. Prior to the beginning of construction for Chimney Hollow Reservoir, the Subdistrict shall provide Grand County with a copy of an executed agreement between the Subdistrict and the wastewater treatment provider(s) to mitigate nutrient loading. This agreement shall include provision for allocating the cost of improvements and additional operation and maintenance costs, if any, associated with those improvements.

Condition 21. The Subdistrict shall submit the Nutrient Reduction Plan required by Bureau of Reclamation to Grand County for review at the same time it is submitted to Bureau of Reclamation and the Corps of Engineers.

Condition 22. Within six months of issuance of the last Record of Decision for the 2012 WGFP, the Subdistrict shall submit to the County for review and approval of a robust monitoring plan to assure that nutrient loading from the 2012 WGFP for total nitrogen and total phosphorus is reduced to the 1:1 level that the Subdistrict has agreed to achieve.

Within six months of issuance of the last Record of Decision for the 2012 WGFP, the Subdistrict shall submit to the County for review and approval a monitoring plan for manganese, bioavailable mercury, dissolved oxygen, and chlorophyll a in the Three Lakes. The plan should also include monitoring for Secchi disc depth July through September of each year in Grand Lake and Shadow Mountain Reservoir. The monitoring plan shall include a schedule for monitoring and reporting and Subdistrict shall provide a publicly accessible data base, and submit to Grand County sunnnary reports on a schedule and in a form approved by Grand County. Following implementation of the WGFP, if monitoring shows increasing trends in manganese, bioavailable mercury, or chlorophyll a, or decreasing trends in dissolved oxygen and Secchi disc depth in Grand Lake, the Subdistrict and Grand County will evaluate and determine the cause for the changes in the trends. If it is determined that these trends are attributable to the WGFP, the Subdistrict will develop and implement a mitigation plan to eliminate the impact of the 2012 WGFP on those constituents.

**Criterion 1(e) The Proposed Water Project is Capable of providing Water Pursuant to Standards of the Colorado Department of Health.**

This Criterion does not apply to this project.

**Criterion 1(t) The Proposed Diversion of Water from the Source Development Area Will Not Decrease the Quality of Peripheral or Downstream Surface or Subsurface Water Resources in the Source Development Area Below that Designated by the Colorado Water Quality Control Division on January 15, 1974 and Effetive June 19, 1974 or Below Stricter Standards Subsequently Adopted.**

The Permit Authority finds that with regard to Criterion 1(f) there are impacts caused by the 2012 WGFP, which would be mitigated with the following conditions which shall be met by the Subdistrict:

Condition 23. Installation of the real time water temperature gauges required by the Fish and Wildlife Mitigation Plan shall be a condition of this 2012 Permit and the Subdistrict must verify every spring, before the beginning of pumping, that these gauges are in good working order, that they remain so during the time of the year when the standard is in effect, and that they are replaced or repaired when necessary and timely to their need in reporting temperature.

Condition 24. The Subdistrict will address temperature mitigation as follows:

- Temperature Thresholds. For the purposes of this Condition, the threshold temperatures will be the stream temperature standards adopted by the state Water Quality Control Commission then in effect.
- Grand County, Subdistrict, Trout Unlimited, Upper Colorado River Alliance will not, and Subdistrict will assure that Northern Colorado Water Conservancy District will not, independently propose changes to the temperature standards for the reaches affected by the WGFP without first working through Learning by Doing.

Under the currently applicable temperature standards, the following would apply.

- MWAT Chronic Threshold Exceedances- Reduction or Curtailment ofWGFP Pumping. At such times as the Subdistrict is diverting under the 2012 Permit and the Weekly Average Temperature (WAT) exceeds the MWAT Chronic Threshold, the Subdistrict will reduce or curtail WGFP pumping at the Windy Gap diversion to the

extent necessary to maintain temperatures within the MWAT Threshold. Reduced pumping may not be sufficient to maintain temperatures below the threshold.

- DM Acute Threshold Exceedances- Reduction or Curtailment of Pumping for the WGFP and the original Windy Gap Project (under both the 2012 Permit and original Windy Gap Project Permit). At such times as the Daily Maximum temperature is within 1°C of the DM Acute Threshold, the Subdistrict will reduce or curtail pumping for the original Windy Gap Project or the WGFP at the Windy Gap diversion to the extent necessary to maintain temperatures within the DM Threshold. Reduced pumping may not be sufficient to maintain temperatures below the threshold. In the future, the 1 degree buffer may be altered, based on experience, to maintain compliance with the DM Threshold.
- Limitations on Reduction or Curtailment of Windy Gap Pumping or WGFP Pumping. The temperature mitigation measures identified above will be suspended in the event that and at such times as WGFP or, in the case of acute standards for both WGFP and the original Windy Gap, stops pumping and the temperature does not improve based on actual measurable effect. In that circumstance, WGFP and/or original Windy Gap may resume pumping. The LBD process will be used to evaluate the effect of the WGFP on temperature exceedances. Whether curtailment of pumping improves stream temperature will be tested on a periodic basis as determined by Learning by Doing.
- Use of the Windy Gap Bypass Valve and Auxiliary Outlet. The use of the Windy Gap Project Bypass Valve and Auxiliary Outlet will be considered by Learning by Doing, as appropriate.

Condition 25. Because the delivery of the 10825 endangered fish water from Granby Reservoir is an essential consideration for compliance with the Endangered Species Act and compliance with the temperature standard, the Subdistrict must participate in securing approval of the 10825 agreement and must arrange with Northern to do the same.

Criterion 1(g) The Proposed Development and the Potential Diversions of Water from the Source Development Area Will Not Significantly Deteriorate Aquatic Habitats, Marshlands and Wetlands, Groundwater Recharge Areas, Steeply Sloping or Unstable Terrain, Forests and Woodlands, Critical Wildlife Habitat, Big Game Migratory Routes, Calving Grounds, Migratory Ponds, Nesting Areas and the Habitats of Rare and Endangered Species, Public Outdoor Recreational Areas, and Unique Areas of Geologic, Historic or Archaeological Importance.

The Permit Authority finds that with regard to Criterion 1(g) there are impacts caused by the 2012 WGFP, which would be mitigated with the following conditions which shall be met by the Subdistrict:

Condition 26. Within six (6) months of issuance of Record of Decision by the Corps of Engineers for 2012 WGFP, the Subdistrict shall prepare and submit to Learning by Doing Management Committee, for review, approval and implementation, a fish and aquatics invertebrates monitoring plan. The monitoring data shall be provided to the Learning By Doing effort and monitoring shall continue as long as the Learning by Doing effort requires this data. If the bypass/through is constructed, the Subdistrict shall adapt and fund the monitoring plan as necessary in consultation with the Management Committee of Learning by Doing.

Condition 27. If a bypass/by through channel is constructed the design shall include a plan for minimizing blowing dust. If such plan is implemented, blowing dust shall not constitute a violation of the 1980 Windy Gap Project 1041 Permit or the 2012 Permit.

Condition 28. The bypass/by-through study shall commence on or before issuance of this 2012 Permit. If the results of the study demonstrate that the bypass/by-through will benefit the



Colorado River as defined in the Scope of Work/Request for Qualifications (RFQ) Windy Gap Reservoir Modifications Study, November 2012, RFQ# PBA-1324, implementation and construction of the bypass/by-through shall proceed in accordance with the Windy Gap Bypass Funding Agreement.

If the bypass/by-through is implemented and constructed, the Subdistrict shall contribute no less than \$2 million.

Condition 29. If, during a five (5) year period, natural conditions meet or exceed flows of 600 c.f.s. required by the Fish and Wildlife Mitigation Plan so that the Subdistrict is not required to make releases or bypass water to achieve the required flow, and a flow of 1200 c.f.s. has not occurred for 72 consecutive hours, then in the sixth year, Subdistrict shall provide a 1200 c.f.s. flow for 72 consecutive hours.

Condition 30. Subdistrict shall prepare and submit to Grand County, for approval, a monitoring plan to establish a baseline for riparian vegetation along the Colorado River From Windy Gap Dam to the lower terminus of the Kemp-Breeze Wildlife Area and on Willow Creek, below Willow Creek Reservoir, within sixty (60) days of issuance of the Record of Decision by the Corp of Engineers. The operation of the WGFP will not adversely impact the distribution and composition of riparian and wetland vegetation along the Colorado River below Granby Reservoir and below the Windy Gap diversion, and on Willow Creek, below Willow Creek Reservoir. The Learning by Doing Management Committee will determine if additional follow-up monitoring of riparian vegetation is necessary based on observed conditions.

Condition 31. See Condition #8.

BE IT FURTHER RESOLVED that conditions# 6, #7, #8, #10, #17, #19, #21, #22, #25, #26, #30, and #31 above are, in whole or in part, precedent to and must be met prior to the effective date of the 2012 WGFP Permit; and

BE IT FURTHER RESVOLVED that conditions# #9, #11, #13, #14, #15, #20, #23, #27, and #28 above are, in whole or in part, precedent to and must be met prior to the use of the 2012 WGFP after the 2012 WGFP Permit becomes effective; and

BE IT FURTHER RESOLVED that condition #1, #2, #3, #4, #5, #6, #7, #10, #12, #15, #16, #18, #19, #22, #23, #24, #26, #27, #28 and #29 above, in whole or in part, are subsequent to and must be met after the 2012 WGFP is in operation.
