**RESOLUTION NO. 2020-9-11**

**A RESOLUTION EXTENDING THE STAGE TWO FIRE BAN/RESTRICTION, FIREWORKS SALE AND USE BAN/RESTRICTION, AND INCENDIARY DEVICE USE BAN/RESTRICTION, DECLARED PURSUANT TO ORDINANCE NO. 20 IN GRAND COUNTY RESOLUTION NO. 2020-8-4**

WHEREAS, on August 11, 2020, the Board of County Commissioners of the County of Grand, State of Colorado approved Resolution No. 2020-8-4 declaring a Stage Two Fire Ban/Restriction effective Thursday August 13<sup>th</sup> through Saturday September 12<sup>th</sup>, 2020; and

WHEREAS, the authority for issuance of that Stage Two Fire Ban/Restriction, as well as the BOCC’s findings of competent evidence that the danger of forest or grass fires is high, have not changed and the BOCC finds that, for the protection of the health, safety, and welfare of Grand County, the August 13<sup>th</sup>, 2020 Stage Two Fire Ban/Restriction should be extended to, and including, October 13<sup>th</sup>, 2020, unless earlier rescinded.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF GRAND COUNTY, COLORADO, THAT THE AUGUST 11<sup>TH</sup>, 2020 DECLARATION OF STAGE TWO FIRE BAN AND RESTRICTIONS INSTATED BY RESOLUTION 2020-8-4 BE, AND HEREBY IS, CONTINUED TO, AND INCLUDING, OCTOBER 13, 2020, UNLESS EARLIER RESCINDED.

BE IT FURTHER RESOLVED, that all findings, provisions, declarations, and other terms of Resolution 2020-8-4 are incorporated herein and remain in full force and effect through the expiration of this extension of Resolution 2020-8-4.
