

Board of County Commissioners

The Board of County Commissioners is elected by registered voters in the county and is designated as a representative per district. Commissioner James Newberry is the representative of District I, Commissioner Nancy Stuart is the representative of District II, and Commissioner Gary Bumgamer is the representative of District III.



This office is the Building Authority for the Towns Granby, Grand Lake, Hot Sulphur Springs, Kremmling, and all unincorporated areas. If your project is within the town limits of one of the locations listed above, start with the Town in question to have them review and sign-off on their zoning authority, then bring your application packet to the County Building Department. If your project is in unincorporated Grand County, bring your application packet directly to our offices. The County Planning and Zoning Department will review for zoning. Some subdivisions impose restrictive covenants which require approval of an Architectural Control Committee on plans for construction. Have your plans reviewed and approved by any external committee before placing them for application with the County Building Department. In addition, many subdivisions have plat restrictions which require soil testing, engineered foundations, etc. Contact the County Zoning Office to find out what your subdivision restrictions may be.

Obtaining a building permit for construction within Grand County can be a relatively simple procedure. Allow ten days to two weeks under normal circumstances (longer during construction season) from the time you submit your application until your permit is issued. If you live out of the County it's recommended that you be prepared to make a couple of visits during business hours Monday through Friday to properly execute your application and permit issuance, following some basic guidelines.

Department of Planning and Zoning and Geographic Information Systems

The Department of Planning and Zoning is the primary point of contact for land use, land development, zoning and code enforcement in Grand County, Colorado. Our staff provides assistance in responding to questions by the public, acting as a clearinghouse to the public on land use and/or zoning codes, regulations and requirements that affect the use of the land. The Department is responsible for the pre-building permit site inspections, required prior to the submittal of a building permit, and coordinates site specific office and field inspections.

Staff review and prepare recommendations regarding land use changes, special use permits, vacations, and zoning variances to the appropriate Grand County governing body (Board of County Commissioners, Planning Commission or Board of Adjustment).

As one of the fastest growing mountain communities, the changing demographics, and increased demand for services and support has created a need to provide electronic information to the general public. We encourage you to visit the Department's home page, www.co.grand.co.us/planning.html to review detailed information regarding the wide variety of topics of which staff provides oversight. Please contact the home page for information related to Grand County regulations, zoning maps, Planning Commission and/or Board of Adjustment agendas, or call the Main Office number (970/725-3347, ext. 14) for additional information.

The Grand County GIS Department was formed in 1997 for the purpose of creating a Geographic Information System capable of efficiently and effectively meeting the organization's geographic information needs.

The GIS departmental goals are to coordinate the human, capital and fiscal resources to build the major base map layers critical to the county agencies. The numerous project benefits include; eliminating data redundancy and duplicate effort, increase in accuracy, currency and the access and availability of geographic information.

The major base map layer in development phase at this time is the Parcel-Property layer. Database coverage's for land use analysis are also being created. Concurrently, the department is responsible for updating existing map data, and coordinating application development.

In consideration to the scope of the project, the provision of mapping & data services to citizens, other government agencies and the business community is limited and based upon resource availability.

Grand County Road & Bridge

Colorado State Highways (CDOT) in Grand County U.S. Highway 40 enters the eastern portion of Grand County on Berthoud Pass and passes through Grand County to the west on Rabbit Ears Pass. Colorado Highway 34 intersects Highway 40 at Granby and travels north to Rocky Mountain National Park and Trail Ridge Road, which opens seasonally, usually Memorial Day through October. Colorado Highway 125 intersects with Highway 40 two miles west of Granby and travels north to Jackson County. Colorado Highway 9 intersects with Highway 40 at Kremmling and travels south to Summit County. Colorado Highway 134 intersects Highway 40, six miles north of Kremmling and travels west to Routt County. Maintenance is performed by CDOT and road conditions are available at 511.

Grand County maintains just over 800 miles of roads, winter and summer. Roads are maintained with regards to daily traffic volume. A list of the order of winter plowing schedule is available on Grand County's website under Road & Bridge at www.co.grand.co.us. Keep in mind that the "Code of the West" applies in most of Grand County meaning that half the snow in the road may end up on your property road frontage. Contact the Road & Bridge department to verify that your road is a county maintained road. Many roads are within private subdivisions and must be plowed or maintained by the private sector.

There are four Road & Bridge districts within Grand County. District One (Fraser area) 970-726-5345. District Two (Granby/Grand Lake area) 970-887-2123. Grand County landfills are located in Kremmling and Granby. Kremmling, one mile north of Kremmling on GCR 22, is open Fridays 9am - 4pm and on Saturdays 9am - 12pm. Granby Landfill, two miles west of Granby, (970-887-2247) is open Monday through Friday 8am - 4:30pm and Saturdays 9am - 4:30pm

Grand County Division of Natural Resources

The Grand County Division of Natural Resources (DNR) is a relatively new department to Grand County government and was created in response to the mounting natural resource issues we face in Grand County. DNR strives to implement sound natural resource management strategies for the protection and enhancement of local natural resources and to educate and assist the residents of Grand County. Many of our efforts are coordinated with private landowners, state and federal land management agencies, and our adjacent sister counties. Successful collaboration with our partners is essential to our success on a landscape scale.

Currently, DNR administers programs and projects that relate directly to Mountain Pine Beetle (MPB) infestations, wildland fire mitigation, fuel load reductions, hazard tree removal along roadsides, biomass utilization, small diameter wood product utilization and open burning. All of these programs and issues are in direct correlation to one larger issue which is Forest Health. DNR tries to address and implement meaningful wildfire mitigation efforts that affect the most acres possible. These efforts whenever possible are coordinated via a collaborative working relationship between the private sector and land management agencies with DNR acting as the middle man or broker.

The DNR noxious weed and invasive species program is one of the most aggressive and successful in the state of Colorado. What is a noxious weed? Noxious weeds are non-native plant species that have been introduced into an environment with few, if any, natural biological controls, thus giving them a distinct competitive advantage in dominating and crowding out native plant species. Biodiversity and ecosystem stability are threatened by noxious weeds as are production agriculture and recreational opportunities. DNR incorporates an integrated weed management strategy that includes cooperative partnerships, education, and control methods that include cultural, physical, biological and chemical uses.


The Grand County Sheriff's Office provides Law Enforcement for all of unincorporated areas of Grand County, along with the Towns of Grand Lake and Hot Sulphur Springs.

The Grand County Sheriff's Office operates the County Jail located in Hot Sulphur Springs. The jail is currently a 38-bed facility, it houses prisoners for all the Law Enforcement agencies within Grand County and individuals sentenced by the courts to do jail time.

The Grand County Communications center is the primary answering point for 911 calls in Grand County. We dispatch emergency and non emergency calls for service and provide support for the Grand County Sheriff's Department, Fraser Winter Park Police Department, Granby Police Department, Kremmling Police Department, Grand County EMS, Fire and Rescue, Search and Rescue, Road and Bridge and also for Flight for Life and Airlife medical helicopters while in Grand County.

We have reverse 9-1-1 capabilities that will evacuate a designated area of our County in case of a disaster by calling all telephones in that area and playing a recorded message instructing residents what action to take for safety.

The Grand County Animal Shelter promotes and protects public safety and animal care through sheltering, pet placement programs, education and animal law enforcement. Our purpose is to provide responsive, efficient and high quality animal care and control services that preserves and protects public and animal safety.

The Coroner's Office is a statutory office, which is mandated to establish the cause and manner of death. The CAUSE OF DEATH is the injury, disease, or combination of the two that was responsible for initiating the train of physiological disturbances (brief or prolonged), which produced the fatal termination. The MANNER OF DEATH refers to the circumstances in which the cause of death arose (suicide, natural causes, accident, and homicide). It is often a misconception that the responsibility for determining these vital questions lies with the law enforcement agency; however, this is the responsibility of the Coroner.

Other Responsibilities Of The Coroner

The Coroner's Office provides information, and works closely with other state and federal agencies (Health Department, OSHA, FAA, NTSB, and Consumer Product Safety Commission), local physicians, hospitals, law enforcement agencies, district attorneys, public defenders private attorneys, and insurance companies.

Coroners also provide learning opportunities for many agencies, which facilitates coordinated investigations. Schools and community organizations, as well as hospitals, hospice and nursing care facilities, also receive education about the role of the Coroner's Office.

Coroners in Colorado are required to be Certified Death Investigators through the Colorado Coroner's Association. The "CCA" was formed in 1988 with the goal of providing continuing education for Colorado Coroners. Colorado Coroners take advantage of continuing education provided by the association's programs as well as numerous other training programs provided on the national level.



Grand County EMS is comprised of dedicated men & women who are EMS professionals providing life saving interventions, quality emergency medical care, and medical ambulance transport for the citizens of Grand County and it's more than four million visitors.

Additionally, Grand County EMS performs a multitude of community medical services. These services include CPR & First Aid Training, Emergency Medical Technician courses, High School EMT course, medical professional development & continuing education services, Public Relations presentations, and a blanket of protection with a comprehensive 24 hour a day emergency response services.

And, Grand County EMS provides the medical community with medical support services including Paramedic Advance Life Support medical transport services and Basic Life Service ambulance transports.

Plus, Grand County EMS strives to provide the community's emergency medical services through a proactive and fiscally responsible billing and financial management plan to not over burden the Grand County taxpayers.



Grand County Airports

For the airport in Kremmling, Grand County has:

Completed an approved layout plan in the effort to lengthen the runway more to the east, which includes expanding safety areas near the field to safely accommodate the larger planes using the airport.

Remarks: RY 27 - right traffic. Caution - wildlife on and in the vicinity of the airport fall through spring. Agricultural, helicopter and ultralight operations in area. Activate lights and nav aids CTAF. Denver RCO - 122.3. For more info call (970) 724-0611.

Noise/Landing Procedures; Land RY 27 and takeoff RY 9, wind and weather permitting.

Airport Services: 100LL, Jet-A. Attended daylight hours. 24 hr. self-service credit card fuel system available. Overnight tie-down fees.

Recreation: Green Mountain Reservoir (20 miles S), Hot Sulphur Springs (20 miles E), Rocky Mountain National Park (35 miles NE), Silver Creek/Winter Park Ski Resorts (45/55 miles SE).

For the airport in Granby, Grand County:

Is continuing in the process of allowing for expansion and improvement of the runway, which is dependent on federal and state funding cycles. The plans envision safety areas around the airport, widening the field and adding improved lighting.

Remarks: RY 27-right traffic. Takeoff to E only by experienced pilots due to rising terrain. Ultralight activity 3 miles S of arpt daylight hours surface to 2000 AGL. Runup pad at RY 27 threshold lighted as TWY; drop off at end of RY. RY 9 relocated threshold 85' and RY 27 relocated threshold 305. Activate lights CTAF. For more info call (970) 724-9428 or see www.granbyairport.com.

Noise/Landing Procedures: 9000' MSL all aircraft.

Airport Services: 100LL, Jet-A. Unattended. 24 hr. self-serve credit card fuel system available. For fuel problems call (970) 887-2123

Grand County Assessors Department

We at the Assessor's office are dedicated to ensuring a helpful atmosphere in order to educate and serve the community by providing accurate, uniform and equitable value for ad valorem taxation.

Regardless of whether you reside within a town or the county, the Assessor's Office will assess your property values every odd numbered year. The cost, market, and income approaches to value must be considered in the valuation of non-residential improved property. Residential improved property can only be valued based on the market approach. Property is valued as it existed on January 1 of the current year. Property tax is calculated by multiplying the assessor's appraised (actual) value of the property by the assessment rate to get the assessed value. The assessed value is then multiplied by the mill levy.

Mill levies are the rates of taxation set by each taxing authority, not the Assessor's office. Each tax authority has a district boundary. A taxpayer's total mill levy is calculated based upon where their property is located. The county, towns, schools and special districts each have a separate mill levy, which is indicated on the annual tax bill you receive from the County Treasurer.

In general, property tax liability will NOT increase at the same rate that actual value does. If you have any questions on how your property has been valued, contact the Assessor's office. If you have questions regarding collection or payment of property taxes contact the Treasurer's office. We are committed to courteous, effective, and friendly service; striving for honest, clear and timely communication with all customers.

We endeavor to promote a positive, team-oriented work environment while pursuing state of the art resources to efficiently meet our goals and statutory obligations.






Grand County Attorney

Pursuant to C.R.S. § 30-II-II8, the Board of County Commissioners for the County of Grand, State of Colorado has determined that County interests require the employment of a County Attorney, whose office is responsible for advising and representing the Board in matters related to County operations, including litigation, negotiation, contracts, collections, and legislative services. The County Attorneys Office is currently comprised of the appointed County Attorney, an Assistant County Attorney, and a Paralegal professional. The current County Attorney, Anthony J. DiCola, has served in that capacity since 1980.
